

The Area

The adjoining meadows and timbered hillsides have also been managed to provide the greatest habit for the game in the area such as elk, deer, many others.



Trophy Hunting Opportunity

One tag will be available each season to hunt Rocky Mountain Elk on the property. This ranch has been managed to provide some of the best habitat in the area for big game, with good feed, cover and water. Stunning numbers of elk reside on the place, including trophy bulls that have not been hunted for nearly twenty years.

Residence

The property has a 3-bedroom; two-bath home with a view overlooking McCoy Creek as it winds through the lush meadows. Other features include a large master bedroom, woodstove, wood deck with awning, newer windows throughout, and a dual water system that can be converted from the well to a spring automatically.
