- The site features 800 AMP electrical service, three (3) flower rooms, one (1) dedicated vegetative room, one (1) mother room, and one (1) clone room, along with approximately one-hundred (100) Gavita RS 1900e LED fixtures.
- It has 12' ceiling heights, a large parking area, and a recently replaced roof.
- Advanced cultivation infrastructure includes TrolMaster and Aroya environmental control systems, eight (8) 5-ton HVAC systems, extensive dehumidification and humidification systems, and a fire/CO₂ monitoring system.
- The site also includes a dedicated irrigation/water treatment room with reverse osmosis water treatment and city water supply.
- Surrounded by several national tenants in the area's established industrial district.

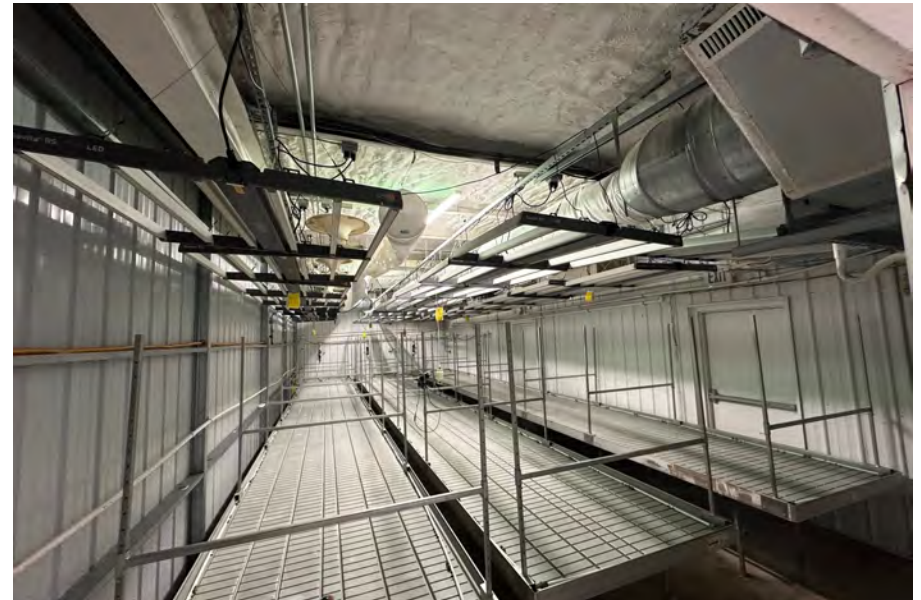

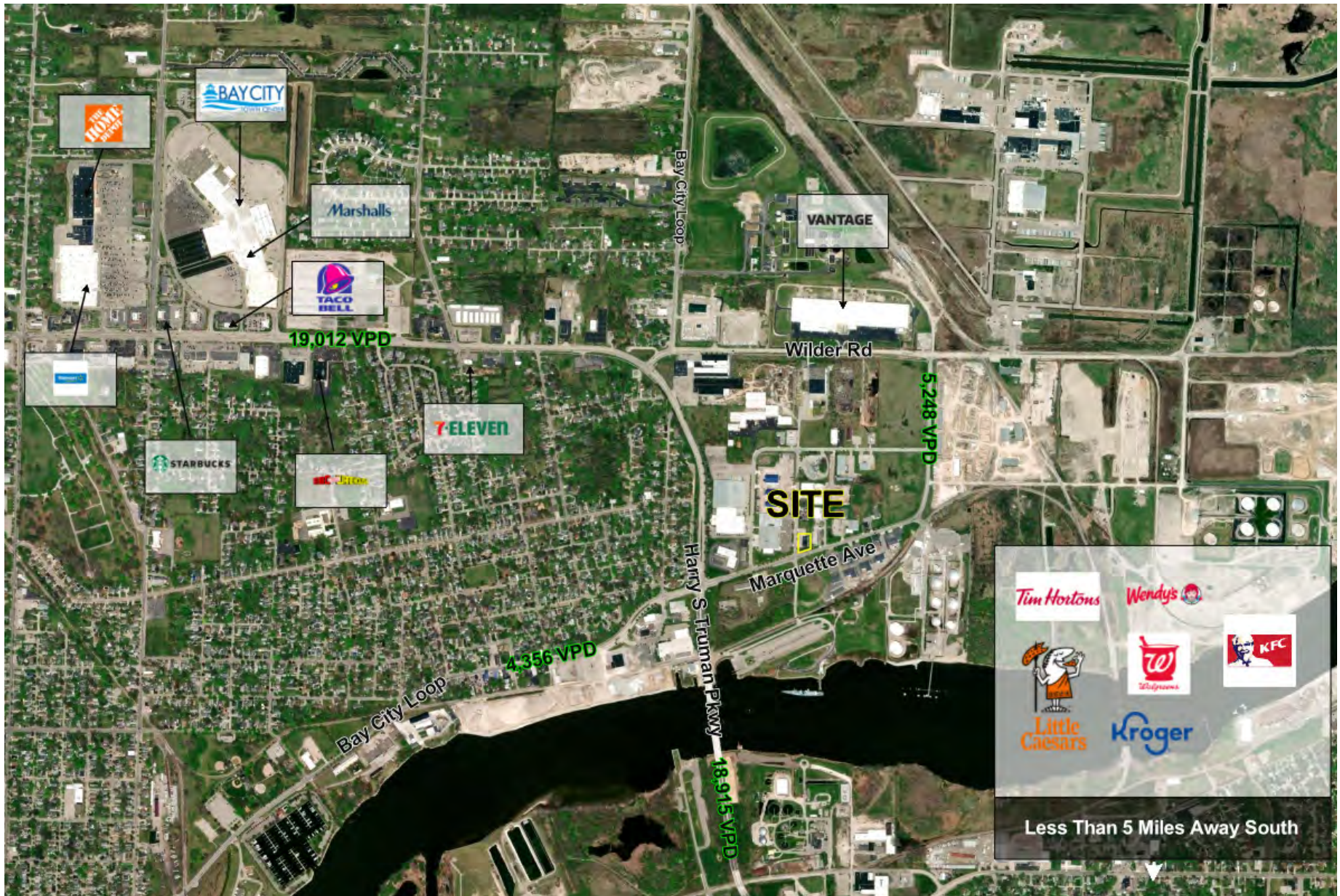
